Whilst I like arts and culture - in tough economic times do we need a revemped town centre? Do we need lots of \$ spent on processes on whether a project should go ahead or not? If think we need to concentrate on the basics - water/waste water/ rubblish/recycling/ reducing plastic usage etc. remember that whilst you think a small weekly cost is easier - (rubblish here) it that some are only accessing that service monthly or less so that I bag that may cost \$5 per week is expensive at \$20 once a month. If there was just the collection costs in the bag included - people could be entitled to recycle more. I.e. Same cost per bag collection whether it was weekly or monthly. Perhaps instead of gardens that need seasonal plantings (which I do like) - have more that have perennials and only a few seasonal? Or like in the childrens park, a garden with a water feature where the public can water? Or children can play but excess water goes into the garden?

Building houses. This is not the Councils role. You say you don't want a town of retirees or holiday homes. Using Council land to build homes wont change this. The solution would to be to look at what other Councils are doing in this space, such as Rotorua and charge commercial rates on short term rentals such as AirBNB's. I understand form the Council they estimate there are 1400 AirBNBs in Taupo. Even if 10% of these properties went back into the long term housing pool that would mean another 140 houses available for workers. The bulk of these Air BNB's attract low value tourism, they self cater and the income from the properties generally leaves town. They make the town a very unpleasant place to work. The Council is not managing the issues they cause, as the Council doesn't provide a full compliance service outside work hours or over the weekend. The AirBNBs sector is bad for the brand and makes Taupo ugly.

Building more houses will also increase the infrastructure needs driving up costs. Why not intensify down town, the basic infrastructure is in place and keeping people in town will assist with to drive demand in the downtown hospo sector and keep the vehicle numbers down as people can walk to venues.

With a possible 5 bins to deal with, where do we put them all? in the Wharewaka subdivision, it is understood there are covenants about what can be placed where. At our place, we don't have easy access to take wheelie bins around the back of the house. Nor would be be inclined to do do so either. Either we place them in the front of the house in full view of the road or they need to be near the bedroom windows. Neither is a good

option, the subdivision would look like a slum in a short time.

The current 2 bins work well for us, we only put out a bag every 2 weeks or so. We don't have food scrap waste as this goes into the vege garden. TDC should encourage households to bury their food scrap waste, vegetable only, not bones or meat, into a garden. We hear so much about the cost of food, it is easy to grow it with the food waste for compost, the soil improves quickly. The food scraps in a bin located outside also brings its own problems with cats, dogs, ants, cockroaches, flies and other vermin. Not something we would want to put in our back yard thank you.

On one hand TDC talks about reducing the use of plastic and here we are promoting a mountain of plastic in the form of wheelie bins. Our net use of plastic will increase substantially, these bins will fall in to disrepair, get used for other purposes other than rubbish and the ratepayer pays for it. TDC should be promoting less plastic in all our daily use. It is considered that these bins will in due course be another blight on the landscape with broken bins dumped along the road along with other rubbish.

if the option will be to discontinue the use of 60L plastic bags, then our household would only accept one bin for all waste streams as we dont have the room for 4 or 5. Does TDC have a position on that and would it be deemed compulsory to take 5 bins? Would you pick these surplus bins up if they are not required by the household? We would be lucky to fill one bin a fortnight.

You mention that people put out more than one rubbish bag, well that is why the bags have one sticker. It is paid for by the user. TDC is trying to manage behaviour. Moving to wheelie bins limits how much rubbish can be thrown out and encourages us to recycle more. You can therefore expect to see a lot more illegal disposal. If the rubbish bin is filled up in a week and it not collected until the following week, where do you think the extra rubbish will go? along the ETA as you can already see, or in park and reserves or anywhere else? People do not act rationally and will not necessarily reduce the amount of rubbish, especially when the amount of packaging across any purchase is unregulated and the consumer has to get rid of it. If it requires 2-3 bags for a family, so be it, they pay for it. But if the volume is limited by a bin, then it would have to be carried over until the next fortnight. That wont happen in the majority of cases i suspect.

People are inherently lazy, just look at any park around town and see what happens. You also presume that more rubbish is produced by a family during the summer where you will have a weekly collection. That is ok for holiday houses and the like, but residents would generally produce the same amount of rubbish each week throughout the year. So what happens when the bin is filled each week and then the family needs to wait until the following week. You are suggesting that people will act nobly with their rubbish, and presume that people will recycle more, well good luck on that notion. For someone who has had involvement in urban waste management projects, i have yet to see a service that functions as initially planned.

it is suggested you have answered the problem yourself on page 18 where you describe the disadvantages as i have above. No point in giving households a bunch of wheelie bins that may not be well utilised, they will be repurposed for other uses and comes at ratepayer cost. That may save a few hundred thousand dollars too. \$953k in interest charges over the life of the plan? have we got that much money to throw around? You confuse the amount of recycling with the amount of general waste. A small wheelie bin wont necessarily encourage recycling at all, that is so naive to suggest that.

You contradict your own argument by saying at peak times there is a large volume of rubbish and recycling which creates collection issues. Then have the contractor address that in his tender bid. You also naively think that more rubbish means more recycling, that does not necessarily follow. On the one hand TDC encourages a host of national and international events, and then says the landfill capacity being used up faster. HELLO! where have you got your head? more people brings more rubbish, that is simple enough. Why does the ratepayer now have to deal with this change in the plan to effectively limit the volume that can/will be

collected each week because TDC actively encourages Taupo to be the event capital of the country. Perhaps a visitor levy of \$10 pr person for all event registrations to allow for the increase in rubbish at the tip. They come from afar for a good weekend, loaded with their goodies from their house and then dump the waste, usually with recyclables, in the nearest bin. Do they take it home? of course not, and why would they.

So that one wont fly. Similarly with food rescue, tonnes of good product is dumped each week as they have passed their use by date but are still ok. Health issues, and then why would a supplier give it away when they could have sold it.

We have a mountain of waste as a result of the amount of building construction and increasing population generating a bigger mountain of waste, let alone waste generated from weekly events brought into town, and you you want to look at coffee cups? does that also include single use water bottles that have littered the country? That would have a very small impact on the dump compared to building waste. Checked on the skips at every building site lately?

### 1.11 Any other feedback?

The LTP does not make any specific reference to the waste generated as a result of commercial events held in Taupo or even addressed in the LTP. How are these events factored into the life of the current dump site? What is the percentage of volume from events compared to residential waste? Do event organisers have limits on how much waste can be disposed of as per TDC inference that TDC want to reduce residential rubbish volumes, mainly to extend the life of the current dump site, and stated savings on purchasing carbon credits?

In the case of events at Taupo, does TDC have information on the volume of recyclables that are rejected due to contamination. It would be unlikely that the general visiting public would be so incentivised to ensure only clean and suitable material is placed in the obligatory bins at an event. This has been witnessed first hand, so it is presumed most of this material is classed as general waste?

What restrictions or costs are levied on event organisers in terms of waste disposal? If we have an event that brings in 20,000 people for a weekend, that is around twice the permanent residential population, and the visitors produce the same volume or more of waste typically produced by the residents over a weekend, most of which is general or contaminated recyclable waste.

How will TDC address rubbish generated in excess of the 140L bin per fortnight in the off-peak times? This is only just over 2 X filled 60L bags that would be collected weekly. How does this affect those home-office households? Will this need to be dumped by the residents themselves?

Will 60L bags still be accepted at the dump with the sticker? If not, why not?

Would the 5 bins planned for each household be obligatory? Can the householder choose which ones they would accept? If not, why not?

is recycling of plastics, bottles and paper obligatory for any residential property?

What happens to all the wheelie bins at the end of the 10 year plan when it might be decided that it has not been such a successful idea? Does TDC have a costed exit strategy for such an outcome?

Not quite such an ambiguous question as I can sort of infer that I am agreeing to the wheelie bin option. I believe this is gunna become a standard system nationwide by regulation so that's that! However, I believe that the wheelie bin rubbish collections should be individually charged to the householder, perhaps by some sort of sticker or bar-code system so that people don't unnecessarily clog our landfill. Do the minimum number of collections needed year round...perhaps only fortnitely or even monthly overall, even for food scraps to save costs.

I believe the government is rolling out (through the councils) its standardised system for recycling & rubbish. Most councils have already adopted this, and it is almost certain that Taupo will eventually have to also, but hopefully it could be delayed, or have other tweaks that make it more suitable for people.

- The bin system should be cheaper overall but it does not show up that way. A 1 man operation, and probably quicker to complete the run, 1 truck per week instead of 2 trucks each configured differently should be cheaper.
- 2. There should be a way that low users can save money (& help the council extend the landfill life and help the environment) in comparison to high users...e.g. with today's technology (Bar codes, GPS, weight detectors on the lifting device) it should be easy enough for householders to be charged for the number of times a bin is put out, and even by the weight of the bin, rather than a standard charge for all on the rates bill.

I believe a council over Taranaki way has bar code readers on it's trucks that collect the wheelie bins so that householders are only charged for the times their bin is collected. Taupo should do the same. A part charge is fine on our rates (as I belief there is at present) with the rest of the cost being "user pays" as it is at present with our sticker system.

Also see letter to editor in Taupo Times, June 28 2024, page 6, from Fred Beckers titled "Wheelie Bins". He makes the same point, though I think his figures are inaccurate as he ignores the current standard charge for all householders currently on our rates, so the difference between "current" & "Wheelie Bins" is not actually as great as he claims, though it is still substantial.

- 3. Difficulty manipulating bins, especially for elderly or disabled, and on long or steep driveways, paths with steps etc. No opportunity for such people to be able to put their bag & small green bin in their car/mobility scooter to get it to the road.
- 4. Air B&B's should be charged (under either the old or new system) at the same rates as industrial & commercial enterprises, not at domestic rates. I observe that they do not generally recycle, simply putting everything in a bag. This should surely incur extra charge...as it does to a certain extent presently as a typical B&B pays perhaps 4 bags a week instead of 2 bags plus recycling (if they bothered to). Under the new system...all will go straight in either bin & so a problem with mixed up rubbish & recycling too...and with only paying the same as a careful domestic family who do the right thing with recycling as well as minimising rubbish.
- 5. Problems finding where to put 2 wheelie bins, a black glass bin & a food bin vs our current smaller less numerous bins & bag. e.g. at our house...currently we keep green & black bin plus rubbish bag in a cupboard in the garage. Where would we put 2 wheelie bins? Garage is too small, and round the side of our house by our camper would make it very hard to get them out, and on the deck by back door would be pretty unsightly & difficult to get them down steps then down steep drive, and outside front door is culturally inappropriate & unsightly. Another example...the 30 or more units at Wharerangi village...easy enough to have the small bins/bag in the "utility cupboard" at the back door, but wheelie bins only could be accommodated at the front of each unit. They can't be carried through the units from back door to front in the way that the bins & bags can, and at the front doors they will

make the place look like an industrial worksite and limit the sheltered space where the elderly sit outside their front doors to chat & tend to their pot plants.

- 6. Bins alternately collected weekly for rubbish, then recycling. People will confuse the weeks. People will be stuck with no ability to get rid of rubbish sooner than a fortnight if they wish to do so e.g. if going on holiday or if they do have a lot of rubbish on the odd occasion...they can't even fit the bin in their car to take it to the dump.
- 7. Wheelie bins are liable to blow over (or be pushed over by vandals) & not solve the current problem of recycling blowing out of the green bins and animals ripping bags open.
- 8. We won't be able to take our rubbish bag to the landfill as there won't be bag stickers to buy so that means we will have to pay the minimum general waste charge (\$21)? That could also impact on those without a rubbish collection such as rural dwellers & those at places like Miro Court who don't have domestic rubbish collections.
- 9. No incentive for householders to minimise waste: "Hey we've got a big wheelie bin, we pay whether we fill it or not, so might as well. It won't even matter if we chuck some recycling in our waste bin...saves us sorting after a party!" Vs "Hey, we pay for each bag...lets make it last 2 or 3 weeks by minimising rubbish & recycling as much as possible".

I really don't agree or disagree as the bins are inevitable so there is not an option. The government has decreed (I believe) that councils adopt them as part of standardisation of rubbish & recycling systems. Almost all councils have adopted this. Taupo will have to eventually, and I note that tonite we are staying in Mariborough & I see that Mariborough District Council starts its bin system this week...My sister puts them out tomorrow for the first time ever!

However...although the bins are as inevitable as the sun is gunna rise tomorrow (or so the rooster over the back fence at my sister's tells me), it is the way they should be run that is important. They should cost less overall for whoever is paying than the current system (my gut-feeling experience as an industrial engineer and performance auditor tells me that without even charging council half a million or so as my fee to give the figures that would show it...though I would be happy to accept that from the council!)

Plus the various other points I made..e.g. part standard charge on rates, and part individual charge to the householder set by the number of times they put bin out/volume/weight or whatever. instead of just a standard (and far too high considering cost savings of the bin system) charge on rates. And what (for example) can be done about places like Wharerangi looking like an industrial site with no room left for the elderly to sit at their front door in the sun? And what about people like my poor but happy cousin Mike who lives at Miro Court...has no rubbish collection, has nowhere to put the bins if/when they are brought in even if council decided to give Miro court residents the privilege of having rubbish collected and currently makes his way across the desolate wastes of upper Taupo every month or so clutching his small bag of rubbish with a sticker on it to the "landfill". In future, will he have to pay minimum charge of (is it \$21?) for such a bag?

And what about old people who can't get their bin to the gate because it won't fit on their mobility scooter.

And what about us who have nowhere to put the bins except at our back deck where we entertain the hoy-poloy in summer, or the front door where we can place signs on them saying "Our bins are carefully placed to create street appeal".

I am 1 of 34 site holders/members of Mission Point Campers Association, a private camping ground located at 489 State Highway 1, Tauranga Taupo, Turangi 3382 - the address better known as Mission Point, Waitetoko. Most members come to the camp for several weeks over summer, the long weekends and otherwise whenever it works given their personal circumstances. No member stays permanently at the camp, and typically members leave the camp to return to their permanent homes at the end of a weekend or a long weekend, so putting out a rubbish bag before they leave for collection on Tuesdays (our current collection day) is a workable solution for our members (which would not be the case for wheelie bins).

Accordingly the Proposed option unless modified will not work for members (and holiday home owners) for the simple reason specified as a Disadvantage "Issues for holiday home owners getting wheelie bins back from the kerbside".

We live in Wellington where ratepayers/residents have the option of prepaid rubbish bags or user-pay wheelie

bins. This works for all ratepayers/residents giving them a choice of the option that works best for their circumstances similar to what could work for all ratepayers (residents and holiday home owners) in the Taupo district.

However I would be supportive of a hybrid solution that includes rates-funded wheelie bins for all ratepayers/residents (including holiday home owners) as proposed, provided it additionally allows for pre-paid rubbish bags for ratepayers/residents (including holiday home owners) where wheelie bins are impractical given their circumstances.

It is noted that Taupo district has a large number of holiday homes, and if the Council is serious about providing services that are are workable and of benefit to all ratepayers then it must not adopt the Proposal of ratepayer-funded wheelie bins unless it also allows for the option of prepaid rubbish bags.

It is also noted that a hybrid solution as suggested would incentivise ratepayers (whether residents or holiday home owners) to change to the 'free' rates-funded wheelie bins if practical, and otherwise have to fund the cost themselves of prepaid rubbish bags.

The hybrid solution would allow for holiday home owners who leave to return home on a day which is not immediately before their rubbish collection day to take their rubbish bag(s) to a transfer station (such as the Turangi transfer station in our case). This would not work if wheelie bins are the only option.

3. Carbon Credits.

Council needs to take a firm stand and tell the Government that TDC will take the decision to stop paying the mandatory fee imposed for carbon credits, Just add that to the LTP please.

Here is some relevant support from the Methane Science Accord to help you make a case for not buying carbon credits. "Professor Dave Frame, our leading climate scientist, IPCC contributor and adviser to successive governments has stated that New Zealand farmers are responsible for, at the most, warming from livestock from 1850 to 2000 of 0.0014"C with projected future warming of 0.0004"C between 2000 and 2100. That amounts to 4 millionths of a degree/year — an inconsequential, immeasurable and utterfy irrelevant contribution.

Dr van Wijngaarden a leading Canadian climate scientist recently estimated New Zealand farmers are contributing 0.00000119 degrees C of warmth per year – confirmation of its triviality."

If TDC Councillors cannot dispute this information, then please use it to support not paying for carbon credits in 2024 and beyond. I am sure TDC will find that ALL methane emissions in the district are equally insignificant, TDC must therefore confirm this information with the Government as your reason to stop paying/buying carbon credits for emissions from the tip sites etc.

The saving will be in the millions of dollars, and a saving for all ratepayers, rural and urban. TDC can show some leadership on this matter and lead the way. Ahead of other Councils. The national saving for all Councils would be some \$140 million in the 2023/24 financial year. LGNZ needs to give support for this initiative and get on side with TDC on this issue. Attached is a letter from the Methane Science Accord to the Prime Minister, dated 24 June 2024. Please ensure all TDC Councillors and staff read this letter.

#### Solid Waste disposal.

Someone on Council needs to do some more homework please. Time for Council to think outside the square? As a start, Google this company, Sanivation. Sanivation is a company that operates in Kenya and supports local Councils to tackle waste management issues. Such as design, building and operating fecal studge treatment plants, using a waste to energy model. The raw material is treated through heating at high temperatures (geo-thermal energy could be used) to kill the becteria and then mixed with sawdust (more waste) to make briquettes. On it could be sold as a fertiliser product? Another alternative is incineration of all the local waste on one site. On the west side of the Walkato River where TDC has a pending problem. Incineration is the most widely used waste disposal method in Japan and Japan is now a leader of the world's incineration facilities. Did Council now that less then 1% of household waste in Sweden finds its way to landfills? ANDRITZ is another company that can help with waste incineration and sewage sludge treatment. Council needs to do some research into the alternatives to the current methods of waste disposal. Plastics that are a problem outld be burnt and that would avoid harm to the environment and animals. Recycling costs would be reduced, and rubbish collection would become less expensive, and the potential outcome maybe even profitable for TDC?

#### Hidden Costa?

TDC wage costs are way too high, and the reasons need to be addressed by Council. Rates go up, cost of living continues to go up, employees want higher wages, employment opportunities are reduced. Then there is a crash, and many staff get hurt as they lose their jobs and income. There are no winners. Council needs to do their bit and seriously reduce costs in 2024/25. Your budgets need to be further reduced, in 2024, it is noted that between 2022 and 2023 the staff numbers increased from 351 to present level of 406. Can Council please tell the public why was this necessary? This increase contributed to an increase of staff costs of \$4,516,000, being 18% of the total annual cost that is now some \$29,368,000. What has the Taupo district achieved form this extra \$4.5 million of costs? Please explain and justify your past decision to expand. The TDC Annual Report 2022/23, page 92 states the income from general and targeted rates as being \$82,573,000. Page 109 of the same report lists salaries as and wages as \$29,368,000. That is 35% of our rates is paying for the staff at TDC. + As a Council table surrounded with experienced Councilions, that is surely appalling and an embartassment for your CVs. How did you let it happen?

#### 7. Local Government Cost Index

Following on from item 6, it would be apparent that annual increases are partly due to due to the LGCI. The Local Government Cost Index that has been in use since 2015 sates that rate increases may not exceed the LGCI + 1% for the 2015/25 period. The 2021/31 LTP stated that the rates increase may not exceed the LGCI + 2.5%. NOW the 2024/34 LTP is proposed on the basis of an "affordable benchmark" of LGCI + 5%. Why is TDC using the LGCI and not the national CPI rates for the assessment of rate increases? If it is because TDC is a member of the LGNZ then I see this as another good reason to resign, as has Auckland and Christchurch. LGNZ should not be influencing the TDC Council

#### Turangi wastewater treatment.

You have told the public.

"We've allowed \$6 million in this plan, from 2028 to 2030, to improve our current treatment process and discharge from the Türangi Wastewater Treatment Plant. We'll continue to work with livil and hapú to find a suitable place to discharge treated wastewater to land in the longer term. The alternative option would be to not invest in the current Türangi wastewater discharge site and continue to work with livil and hapú to look for somewhere suitable to discharge the wastewater to land. An initial estimate of the possible cost is \$18.5 million, which would be funded by debt with an impact on rates of around \$58 (average per ratepayer). Despite extensive investigations we haven't yet found a location for this. However, Council remains open to a land-based wastewater solution for Türangi if an appropriate site can be found, in the meantime, the wastewater treatment plant's resource consent needs to be replaced urgently, so we need a short to medium term fix." It is my understanding that Council has spent many months and a lot of money trying to work with the local livil to get a solution. The above statement by Council has failed to present the full picture, so the public do not have full transperency of the results to date.

I trust that you can accept this project is a self-inflicted mess and that Council can now accept that is why you are looking to take a new path. I say the 'new path' needs to be strictly commercial, without 'agendas' that are linked to the past. Start with a clean sheet of paper. This is one of your key tasks and responsibilities. Council must take a serious moment and decide to ensure TDC maintains control and ownership of the treatment process. Council must show some firm and honest leadership in finding a solution that is within your control and set new budgets as will be required to help all Turangi ratepayers.

TDC must look at more options and keep the public informed. Thayt could include the following.

- Agree to search for the best practical and compliant long-term option, that may not be the cheapest.
- Continue with the existing site and make it compliant and useful for the short term.

Plus replace the resource consent, as is required.

Investigate alternative sites that would suit a new treatment plant operation. Near to and able to be connected to the existing sewer pipework as laid.

That could also mean that Council does not have to deal with the local lwi.

Alternatively, a new site will have to be found and purchased. If that is an option, then that is what has to be done.

#### 8. Democracy.

May I suggest that Councillors and staff please read and remember the following definitions. According to the United Nations, democracy "provides an environment that respects human rights and fundamental freedoms, and in which the freely expressed will of people is exercised." The Oxford dictionary definition of democracy. "A political system that allows the citizens to participate in political decision-making, or to elect representatives to government bodies."

9. Who is running the TDC? Christchurch City Councillor John MacDonald is reported recently (19 June 2024) as saying "For a long time now, I've been of the belief that while mayors and councillors might like to think they're running the place. And it's the council staff who really run the place". MacDonald was critical of the elected politicians for letting staff get away with it (running the place), saying that the good councillors make themselves unpopular with staff by asking "challenging questions", but generally "the council staff get away with what they want to get away with". If that sounds like what is happening at Taupo, then the elected persons need to take some action and more control. More leadership, Ask more questions. Referring to a situation at Wellington CC, Minister of Local Government, Simeon Brown, has sided with the critics on Council, condemning CEO Barbana McKerrow's actions, stating "The CEO is acting like a politician when she should be acting like the CEO," How bad is that? Should someone invite Hon. Simeon Brown to your table.

#### Road Cones

Council needs to make, set and enforce their own policy to manage safety for minor road works in the Taupo district. The current practice of lining the street either side of road works with cones and signs and sandbags etc is a big cost and a nuisance for road users. Drivers do not need to be treated as dumb and not able to manage their driving as is the current situation. Common sense and less cones will help reduce the Transport Budgets by 10% or more. Work Safe need to be challenged on this matter, to allow for local needs. Please take a lead for cone management in this LTP.

Dear Mr Luxon

We are deeply concerned about the direction of the country's policies on ruminant methane emissions. Recent science shows previously accepted findings on the warming ability of ruminant methane are wrong, over-stated and counter to New Zealand's interests.

As a result of this new research, we seek a <u>new initiative</u> by your Coalition Government – an international initiative to remove all ruminant methane emissions from any form of restriction and we request your Government leads the effort around the world. New Zealand is ideally positioned to lead such an initiative.

We know you understand the value we bring, as a livestock sector, to the economy and local communities. However, currently, the sheep and beef sector is mired in a period of high costs, falling farmgate returns and is struggling to survive. It cannot meet any new taxes or imposition from methane regulations or mitigation impositions.

The official position that the country could see a 35% decrease in stock numbers, a 29% decline in sheep and beef grass land, 25% of its dairy production lost to achieve climate change objectives is utterly unacceptable. It would devastate farming, rural communities and much-needed exports.

The Global Methane Pledge, signed by New Zealand states, "focusing on standards to achieve all feasible reductions in the energy and waste sectors and seeking abatement of agricultural emissions through technology innovation as well as incentives and partnerships with farmers" so is clear that reducing livestock numbers is unnecessary.

Professor Dave Frame, our leading climate scientist, IPCC contributor and adviser to successive governments has stated that New Zealand farmers are responsible for, at the most, warming from livestock from 1850 to 2000 of 0.0014°C with projected future warming of 0.0004°C between 2000 and 2100. That amounts to 4 millionths of a degree/year – an inconsequential, immeasurable and utterly irrelevant contribution.

Dr van Wijngaarden a leading Canadian climate scientist recently estimated New Zealand farmers are contributing 0.00000119 degrees C of warmth per year – confirmation of its triviality.

These findings come from recent research work confirmed by a growing number of scientists. They apply to all ruminant methane emissions world wide.

The obvious conclusion is that any efforts by farmers to reduce ruminant methane emissions are symbolic, unable to be measured and totally immaterial. It could only be seen as New Zealand farmers making a gesture.

However, we believe that there is a logical and morally sound case for such symbolism to be rejected and all ruminant emissions to be excluded from the UN's IPCC reduction targets and calculations.

 Ruminants rely on feed that is grown using CO2 sequestered from the atmosphere in the photosynthesis process unlike any other Greenhouse Gas emissions that have no offset.

Dr Kevin Trenberth, a leading IPCC scientist said, "This is NOT scientifically sound. It appears to assume that the methane emissions from dairy and meat count, but they do not because they come from carbon dioxide that was already in the atmosphere and was taken up by grass in photosynthesis. Any methane decays on a decade timescale back to carbon dioxide. It is circular. Methane is so short-lived it equilibrates and no extra warming results provided numbers of stock don't change."

- 2. Open pasture used as feed for ruminants releases H2O into the atmosphere through transpiration. This H2O has now found to be oxidised by the effect of sunlight into OH that, in turn, reacts with methane to remove it from the atmosphere. Any given area of pasture feeding ruminants produces significantly more OH that removes a much greater amount of methane than the amount of methane produced by ruminants on an equivalent area. Pasture renewed by feeding ruminants is removing methane from other sources beside that emitted by sheep and cattle.
- New Zealand signed the 2015 Paris Agreement that stated in Article 2 that no measures should be taken that "threaten food production". We feed 40 million people and already have the planet's lowest carbon footprint among food producers.
- Any reduction in New Zealand's food exports caused by taxing or imposed mitigation will lead to the lost production being made up by a country with a higher carbon footprint making a farce of our efforts.
- We note that farm emissions have fallen steadily since 2005 during a period when farm productivity has increased dramatically and pastoral land has been taken by forestry, urban expansion and farmer's own planting of large areas of natives for riparian and shelter reasons.
- 6. We further note a matter of grave concern. The 2023 IPCC AR6 report, page 1016 of Chapter 7, said: "... expressing methane emissions as CO2 equivalent of 28, overstates the effect on global surface temperature by a factor of 300% to 400%". This meant that in one stroke of the pen, former science that hung over farmers, menacingly, blaming them for being the country's major GHG emitter, was upgraded by more recent science. It potentially reduced an individual farmer's liability by many thousands of dollars.

Now, even more recent scientific findings have revealed that liability is further reduced but Government departments and even some industry groups refuse to acknowledge these new developments.

These factors apply to all the planet's ruminants. New Zealand's unique situation is accentuated by having a low population and an absence of heavy industry, so we are ideally placed to lead a campaign to have ruminant methane emissions excluded from penalising measures. We are committed to basing decisions on sound, current science. We do, every day. It is core business for us. We take our responsibilities seriously. We know as a nation we can punch above our weight and lead the world in innovative and sensible solutions.

Having you and your Government lead such a campaign, especially if joined by countries like Ireland, Denmark, Chile etc, and have the United Nations and the IPCC adopt the plan would overcome any potential consumer reaction that may arise from any continuing media aided focus on the negative effects of ruminant methane emissions.

We seek your Government's support for this approach and ask you as Prime Minister, given the importance to our recovering economy, to lead an international campaign to remove any restrictions on ruminant methane emissions.
