So to avoid the situation where the proposed new bins sit on the roadside for weeks on end the current prepay bag sustem must be retained as well

If the proposed collection arrangement is to be altered problems will arise for thost we stay for say ten days when they put out their bin for collection it will inevitably contain both food scraps and rubbish as not enough time will have elapsed to allow for one collection for food scraps and another for rubbish. Hello.

We understand that consideration is being given to introduce Wheelie Bins into the rubbish collection system for Pukawa.

As you know this village is mostly unoccupied holiday homes; at last count there is fewer than a dozen permanent residences in Pukawa yet there are some 220 houses.

Current practice is for rubbish bags and recycling bins to be "put out" for collection on Mondays where property owners chose to dispose of their household rubbish in that fashion. Our own practice is to take our rubbish home with us and only use the recycling facility at Omori when the bottle bin gets a bit high.

We cannot see any merit in a proposal to litter the place with bins. There is a very good chance that if bins are put out for collection they will stay on the roadside until the next time a property owner is back in Pukawa. It is unreasonable to expect that a few elderly owners should wheel empty bins back inside the property of those owners who are not there to do so.

I am aware that in similar villages (eg Whareroa) with similar unoccupancy levels big bins are supplied at some central point in the village. Why cannot recycling arrangements mirror this practice?

As for household rubbish, why can't we continue with the current practice of using bags?

For our part we have rarely seen any problems associated with the current arrangements. So if it ain't broke what is the problem that Wheelie bins are intended to fix?

I am writing to express my strong opposition to the Council's plan to replace the current weekly rubbish bag collection with wheelie bins. As a holiday home owner in Pukawa I am deeply concerned about the implications of this change, both financially and practically.

First and foremost, the introduction of wheelie bins represents an unnecessary expense that would be added to our rates. As someone who is not permanently residing in the district, the cost of these bins is an unwarranted financial burden. It seems unreasonable to impose such costs on holiday homeowners who are not consistently using the waste collection services.

Moreover, the current system of rubbish bag collection provides the flexibility needed for holiday home owners. We can manage our waste based on our presence in the district, ensuring that we only pay for what we use. Introducing wheelie bins would disrupt this system, forcing us to pay for a service we do not use regularly. This is particularly inequitable given that we already contribute to the local economy through rates and other expenditures.

In addition to these financial concerns, I am fully capable of managing my waste responsibly. I consistently compost my food waste, which significantly reduces the amount of rubbish needing collection. For other waste, I am more than willing to take it to the transfer stations in Turangi or Omori when I am in residence. This approach is not only cost-effective but also environmentally responsible, aligning with sustainable waste management practices.

Hi there, My wife and I are co-owners of a batch in Pukawa.

The current rubbish bag sticker system works well for us as we are rarely there for more than a couple of days at a time. On a Sunday evening we can leave the stickered bag at the top of the lane as we leave to go home, and it gets collected the next day.

The concerns I have about the wheelie bin proposal as I understand it are:

- 1. Bi-weekly collection. I understand the bins are to be emptied every second week. I just can't see how that will work for us as the batch is not occupied every weekend. Do we take it to the top of the lane at the end of our week and hope someone will bring it back? If there was someone in the following weekend, would they have to retrieve a half-full bin before they could use it. And what if it's totally full? (A benefit of the sticker system is you can put out multiple bags if you need to.
- It's not clear to me where the bins would be taken for collection. I've heard there may be centralised locations - that just makes the above problem worse.
- There's also the issue of bins sitting around with rubbish in them for up to 2 weeks at a time. That sounds like a smell issue in the making.

I've not seen any quantified \$ savings for the council by introducing this scheme - so why do it - we like what we have.

Whilst we are permanent residents, the area I believe has a higher percentage of weekend and holiday visitors, this means that refuge bags and the current plastic boxes for recycling are often left out on the days that they vacate meaning it may be up to a week before they are emptied or returned to the property. We feel that this would be problematic with the large bins, during windy periods they could potentially blow into the roads and if full the contents will scatter. We ourselves use the Omori refuge station on a monthly basis to dispose of our rubbish and recycling, we find its opening times work well and it is well maintained.

The rubbish bags are an outdated concept and need to be replaced. I favour a bin over the current bags system as we should be moving away from single use plastic.

I don't understand why the recycling bin need to be so large though, could they not be the same size as the waste given they will be collected fornightly? It seems a significant jump to go to a 240l bin from essentially two crates. It is not clear whether all the waste would go into the single recycling bin, glass in with everything else? This is strange given we've just been asked to separate it all out.

Elsewhere in the country I have friends with large recycling bins and they have issues with the wind blowing them open and have had to get rubber straps to hold them closed. The straps dislodge when the bin is tipped into the truck. Might need to factor this additional cost in for Taupo also.

It would be good if there were options based on the size of the household and their needs. Having two large bins is quite a bit to store at each residential property.

I would personally not use a food waste bin as I have a green waste bin that I pay for separately where vegetable waste can go.

I would prefer to see a greenwaste bin option so that garden waste can be taken care of. It is not clear to me from the proposal whether the waste bin will also take garden waste? I would prefer this to be recycled like I do currently through a private operator. I would like Council to consider a green waste option, even if it was an optional extra added to the rates.

When I worked in Ireland over 10 years ago, they had a pay by weight system for rubbish and recycling. The trucks weighed the bins and people were charge accordingly. This was a great incentive to reduce waste and increase recycling as the costs were different, recycling might even have been free. While I appreciate this would require additional technology, it would likely incentivise good recycling behaviour and might be something to consider for the future.

The current system works well in Omori and Kuratau. Currently, we have to take our rubbish 300m down a very steep hill to a collection point on Te Puke Road because contractors will not come up our sealed right-of-way (to us and five other houses). That works fine for us, but would not be possible with wheelie bins, so we would support continuation of the current service and/or the dropping of rubbish bags and recycling at the Kuratau Transfer Station.

For us, returning wheelie bins 300m up a steep hill is just not viable. The other issue for us is the cost to the council of purchasing the bins, interest cost and annual cost of the service to replace a system that works well. Ideally, if the proposed option does go ahead, we would like to see the ability to opt-out and maintain the status quo (and even if kerbside collection isn't possible, to continue to use the Transfer Station).

I am making a submission as an individual, regarding a section of the above 10 year plan. Whilst I am broadly in favour of what the Council is doing, there is one particular matter I believe should be brought to the Council's affention. It is only a small matter in the grand scheme but it affects a number of ratepayers.

I have been attending the Aqua Fitness classes at the AC Baths for about 6 years now and thoroughly enjoy it, I believe it pays a valuable part in the wellbeing both physically and mentally of those who attend.

Pre-Covid, the classes operated Monday to Friday, post-Covid that was brought down to 3 per week, Monday, Wednesday and Friday. The fees remained the same. Fees were increased sometime in 2022 and again in 2023, a 10% increase then. Then this year, in April, the number of classes were reduced again, the rationale being that they were being brought in line with all other classes at the Events Centre, we now no longer have classes in the school holiday periods.

The end result is that fees have gone up, classes have been reduced significantly, and now you are proposing that fees go up again, this time 23%. This seems to affect a small number of people a much greater than average amount. I would ask that you make this section of the fees a special case and make no increase this year.

Generally I applaud what the Council is doing and how they manage the town.
