I think that the current system needs to change but not to a bin based system.

Because most of the houses in the Omori, Kuratau area are holiday homes, the provision of bins to every household won't work well.

For example, we are at our house on an irregular basis. If we leave bins at the curbside on a Sunday, then go home, what will happen to the bins after they are emptied. We may noit be back for several weeks. The bins will create an eyesore until they are brought back onto our property.

The bins are likely to be blown around in the wind and become a road hazard.

To keep costs under control from a rates perspective, our preference would be to give an option to the

permanent residents for them to have bins collected as per your proposal. For all non permanent residents or for those who don't want to have bins, keep the user pay system of bags and recycling bins. These would need to be delivered to the current transfer station for those who opt out-of the bins. and add a food waste collection service at the transfer station.

For me personally, the amount of rubbish that I create means that I rarely use the rubbish collection, I leave a recycle bin out most weeks that is 1/2 full, the glass bin goes out approx twice per year and the general waste about every 3 weeks. On that basis I would prefer less cost on the rates and a pay-as-you-go service as it makes more sense for me. Where we live currently there is little or no issue with bags and animals but previously living in Kuratau, it was often an issue - however some people solved this by hanging their bags off the ground. Most of the issues come from those who are not permanent residents and may leave bins out days before the recycle/rubbish service is due - not sure this is fixable as it relies on people being sensible with their waste.

### 1.9 Community Funding

There is such a variety of funding that comprises Community Funding that there is a possibility of the 'first-come-first-served' mentality taking over in the new regime - this could mean that one type of Community groups are able to obtain a larger amount of funding than others, simply because they 'got in first'. I would like to see more clarity around how the funding would be divided up/applied for and how decisions are to be made on the validity of requests eg if a music group applies for funding at the same time as a sports group and the committee allocating funds is more sports biased, would the music group lose out?

There has also been some mis-understanding over what is available to be applied for, many groups have a set of assets that are tangible and used until they fall apart eg sports groups have equipment to enable them to function (balls, goals etc) - music groups however require music to be purchased in order to continue to

enjoy the experience of performing - this is expensive (approx \$100 per piece) and has previously not been eligable for funding, even though it is the core foundation of the group. I would like to better understand the requirements for funding requests and for them to be equal across all types of community groups.

I understand that there is a Arts & Culture Action plan, I would like to see how this is linked to the Community funding as this is not clear.

There are very different needs between different community groups, 'ARTS' do not all have the same needs, this encompasses music, dance, painting, drawing, pottery and potentially literature. Equally 'Sports' have different needs to any and all of the Arts groups, I would like to see some understanding and allowances for these differing requirements.

On a side note, I would love to see the Great Lake Centre more readily available to Community Groups at a rate that they can afford and with a guarantee that their booking will not be usurped by a higher fee paying group as i understand is currently the case. Performance groups really struggle to fundraise when there is not a suitable venue to perform in - we tend to use the local churches which are not ideal spaces for medium sized performing groups. To be able to book a concert in the Great Lake Centre would help immensely with creating the right atmosphere and generating a reasonable audience which in turn would help with fundraising.

I have a property in a private subdivision in Kinloch - "The Poplars" 500 Kinloch Rd.

The current system works well for the residents as it is easy to take rubbish bags and recycling bins to the main gate of the subdivision. (the private road is over 2km to the last house so getting wheelie bins to the entrance would be problematic).

Key issues that I see:

- 1) Getting the bins to the front gate for collection in a private subdivision with up to 2km to the collection point.
- 2) The Poplars subdivision has 50 odd bags for collection at the roadside each week. How would 50 wheelie bins be lined up for the truck to be able to automatically empty them?
- 3) 50 wheelie bins on the narrow Kinloch road will potentially be a traffic hazard.

- 4) There are a number of private subdivisions in Kinloch that will have the same issues as The Poplars.

These are matters I would like to see addressed in the next 10 Years, that relate directly to our community, these include:

Good lighting to improve overall safety:

On the road in general – currently we often have to wait months after a street light is reported as not working before something is done, this just would not happen in the urban area.

Broadlands Road intersection – the current lighting is totally insufficient and presents a significant danger to traffic. This is a rural area which is in heavy fog much of the winter, the intersection beyond River Road is much more visible despite being further away.

Security (sensor?) lighting at the boat ramp area would be likely to deter dubious activity.

A Security Camera: located at the entrance/exit of the River Road intersection would be likely to improve security and safety.

Judder Bar/s: speeding traffic presents a danger, especially to the children on the street. During the summer farming contractors with tractors/trailers/haymaking gear etc tend to speed as does some of the regular traffic. The speed limit is often ignored; however, the use of judder bar/s may be an effective option.

Toilet Facility: many people use the River Road boat ramp through the year. A toilet facility is needed for hygiene reasons, as people are using the reserve and general area for toileting. This is unpleasant and a health hazard.

Concrete Access from Road to Property Boundaries: This is general expectation in residential areas – why not River Road?

River Road is a unique community. It has been great to see the work done recently to unify our community and make good use of the amenities we have.

Attention to the points raised above will improve the health, safety and asthetics for residents.

Cat bylaw. Cats are destroying our native fauna. Community groups area spending thousands of dollars and thousands of volunteer hours on trapping for pests in our areas. However, our main pest is cats - both feral and domestic. We need a strong bylaw that is effective and similar to other districts that have already put these into place while we are waiting for a national solution. Simple solution - microchipping and registration of all domestic cats same as for dogs. Then phasing in over the next 10 years of requiring existing cats to be initially on a curfew of being indoors from 8pm to 8am (to stop them roaming and killing all night long for days on end), then requiring all new cats to be either on lead for walking, or in a cat-patio if outdoors. This will enable transition of existing cats as they age naturally and die and ensure all new kittens and cats are used to the indoor life. This will make a massive positive impact on our environment, more so than stopping single use cups etc. This has been done in multiple locations around the world already with very positive effects. Cats carry disease - Toxoplasmosis. This disease causes fetal abnormality and miscarriages and other issues such as infections to immune comprised individuals. By restricting cats to the owners property, it will reduce the spread of this disease as well as many other nuisances such as them defecating and spraying on other peoples properties. We need to stop pussy footing around this cat issue.

Second dwelling on existing sites - this is currently been discussed at the national level. This should be approved in TDC district plans. Currently Kinloch is restricted to one dwelling per section. By allowing a second dwelling (stand alone or connected in some way to the main house) would ensure good use of land and address any housing issues we have in the area.
