We are comfortable with the existing system. We have very little rubbish needing to be collected: most of our

waste goes into our compost bins. This is similar to other elderly folk, as expressed in the le er to the Editor of Taupo Times (final issue). Other, non-recyclable solid waste (cabbage tree leaves, broken crockery, old paint ns etc) we take to the Landfill (and pay). It is true that the current system is not perfect - animals rip the bags open, sharp objects sticking out can injure our collectors, and on windy days recycling items get blown out of the crates. However, although it may seem advantageous to have waste put in large wheelie bins collected by a mechanized system, we suspect there will be unintended consequences such as bins littering the berms outside holiday homes and becoming targets for vandalism. Furthermore, the collector is unable to see what unacceptable material is in the bin before it is emptied into the truck – likely leading to the whole truck load being rejected for recycling because it is "contaminated". Our "rubbish boys" currently do a great job in sorting out unacceptable stuff at the kerbside. We do not have the space inside our garage for large bins, we would find rolling large bins challenging, and cleaning them out much more difficult than the present crates. WE VOTE TO KEEP THE EXISTING SYSTEM + FOOD SCRAP BIN

We would be happy though with a fortnightly collection. Perhaps weekly in Summer and Holiday periods. Holiday home owners and temporary visitors (AirBnB, Rent-a-bach etc) can find out when rubbish is going to be collected by looking on the TDC website – every visitor renting a house has a smart phone these days. Note that we were not impressed by the result of the Consumer rubbish tracking test (using a GPS), exposed on national TV, that showed an aluminium can going to waste rather than to recycling. We hope somebody was sent to the naughty corner.

YES, TDC SHOULD USE LAND IT OWNS TO HELP EASE THE DISTRICT 'S HOUSING CRISIS.

This is a continuing problem. We do not want Taupo to end up like Queenstown with a n extreme shortage of rental housing. Actually, there is no shortage of houses - there is a shortage of available housing. In Rainbow Point, where we live, only about 10-15% of the houses are permanently occupied. We es mate that in the Rainbow Point to Secombe Park area there are likely 500 to 1000 houses lying vacant for most of the year. We do not have an answer for this, but there must be a solution, even if it involves TDC building and operating rental property in conjunction with a private developer , or a scheme such as outlined below.

We suggest that TDC NOT SELL ITS LAND but instead LEASE it , initially to a building Developer/Company then to the persons who buy a new house from this Developer/Company. Over 50 years ago this was how we (in our mid-twenties) got our first house, in Wellington. Covenants could be placed on the arrangement to ensure that low-middle income, owner-occupiers, get the houses; if they leave they have to sell and the covenant remains. It could also be that long-term (say 8-10 years) owners could then free-hold the land at market value; Council then getting the advantage of rising property values.

Water meters?

We approve of Council continuing to install water meters at new properties and for high water users and commercial users, and for the policy of using them to track water leaks. Although for the next few years, there is no intention to charge for water use for normal residential properties, it is not just the volume of water taken, per se, because it comes from an almost inexhaustible lake supply, but the fact that it is treated and this we presume is a significant cost per litre. We suggest that TDC follow some other councils in encouraging private residential owners to install water tanks to capture rainwater from the roof for use in the garden . TDC could make a bulk order, negotiate a discount, and onsell to locals wishing to put in a tank; Wellington or Porirua council have done this , which enabled us to get one via our daughter who lives in Tawa.

Treasury Management Policy

We DO NOT approve of the proposal to change to Net External Debt/Total Revenue Borrowing Limit from 225% to 250%. Council already has a high debt burden. Council only recently revised its debt to revenue limit from 200% to 225% of opera ng revenue. In 2016 Taupo District Council was eighth in the top 10 borrowers, and the highest of all the towns. We have not be en able to see where TDC sits now, but un I that is revealed WE OPPOSE ANY INCREASE IN THIS DEBT CEILING. We detect an unwise "borrow and spend, borrow and spend" attitude. Borrowing in times of high inflation and interest rates is madness.

OTHER MATTERS

Management of cats

To support the great community planning and pest trapping imitative led by Greening Taupo, we ask that TDC tackle the problem of cats (companion, stray, and feral). New Zealand is awash with cats. It is well established that cats are highly efficient predators, known to prey on native birds, lizards, and insects. We ask that controls around cats are included in the Animal Management Bylaw, and propose: a limit of three cats per household, microchipping, keeping cats inside at night, and compulsory de-sexing. There should definitely be regulations preventing the establishment and maintenance of feral and stray cat colonies, and ac on is taken against such colonies.

WE STRONGLY OPPOSE THE COUNCIL PROPOSAL TO INCREASE ITS RATES INCREASES AFFORDABILITY BENCHMARK FROM LOCAL GOVERNMENT COST INDEX (LGCI) + 2.5 PERCENT TO LGCI +5 PERCENT.

Doubtless you will say "if you cannot afford the rates we set then sell and move to somewhere cheaper". Be careful what you wish for. If we sell our absolute lakefront property, it will undoubtedly be to a wealthy Auckland or Wellington family who will come at holiday periods only and, like most of the houses around us, leave it vacant the rest of the year. I doubt if they will spend the amount of money in the town we do over the year; it will be spending at holiday times only, leading to strongly fluctuating business income. Does the business community want to be closely linked only to the volatile tourist industry, like Queenstown. Furthermore, why should we (residents for over 40 years) be forced out.

Financial Strategy

We **APPROVE OF CONTINUING TO FUND 100 PERCENT OF DEPRECIATION OF COUNCIL ASSETS** over the assets' life cycle. However, **depreciation MUST be "ring fenced"**. One of us, who before retirement was in mid-level management at a Government department, has experience seeing depreciation fund s "stolen" to pay for "nice to have" or "pet" projects. There needs to be strict, uncircumventable, rules to stop this: in your example the depreciation on the mower must not be used to install flash rubbish bins, architecturally unique toilets, or sculptures in the park.

Rubbish collection

We are comfortable with the existing system. We have very little rubbish needing to be collected: most of our waste goes into our compost bins. This is similar to other elderly folk, as expressed in the letter to the Editor of Taupo Times (final issue). Other, non-recyclable solid waste (cabbage tree leaves, broken crockery, old paint tins etc) we take to the Landfill (and pay). It is true that the current system is not perfect - animals rip the bags open, sharp objects sticking out can injure our collectors, and on windy days recycling items get blown out of the crates. However, although it may seem advantageous to have waste put in large wheelie bins collected by a mechanized system, we suspect there will be unintended consequences such as bins littering the berms outside holiday homes and becoming targets for vandalism. Furthermore, the collector is unable to see what unacceptable material is in the bin before it is emptied into the truck – likely leading to the whole truck load being rejected for recycling because it is "contaminated". Our "rubbish boys" currently do a great job in sorting out unacceptable stuff at the kerbside. We do not have the space inside our garage for large bins, we would find rolling large bins challenging, and cleaning them out much more difficult than the present crates.

WE VOTE TO KEEP THE EXISTING SYSTEM + FOOD SCRAP BIN

We would be happy though with a fortnightly collection. Perhaps weekly in Summer and Holiday periods. Holiday home owners and temporary visitors (AirBnB, Rent-a-bach etc) can find out when rubbish is going to be collected by looking on the TDC website — every visitor renting a house has a smart phone these days.

Note that we were not impressed by the result of the Consumer rubbish tracking test (using a GPS), exposed on national TV, that showed an aluminium can going to waste rather than to recycling. We hope somebody was sent to the naughty corner.

Options for dealing with wastewater in Taupō North

We approve of a new wastewater plant in Taupō North, and for increasing the capacity of our wastewater connections in Taupō town across the Waikato River, funded by borrowing. Has Council considered or talked to Contact Energy about reinjecting treated waste water from such a plant into reinjection aquifers currently used by Contact, north west of the Waikato River?

Another Waikato River crossing

A nice to have. However, if you read Danyl McLauchlan 's piece in the latest "Listener" (July 6-12 2024) you will see that very very few engineering projects in this country come in on or under budget. Unless planning, permissions, and completing the work is done within a year, I predict that the cost will be well north of \$100 million. The longer it takes the more the cost. You will no doubt say that this time frame would be impossible – Allied troops went from Normandy to Berlin in less time, against opposition.

NZTA funding changes

WE ADVOCATE REMOVING OR RE-PRIORITISING SOME TRANSPORT PROJECTS, OR CHANGING THE SCOPE OF THE PROJECTS TO MEET A SMALLER AVAILABLE BUDGET.

Water meters?

We approve of Council continuing to install water meters at new properties and for high water users and commercial users, and for the policy of using them to track water leaks. Although for the next few years, there is no intention to charge for water use for normal residential properties, it is not just the volume of water taken, *per se*, because it comes from an almost inexhaustible lake supply, but the fact that it is treated and this we presume is a significant cost per litre. We suggest that TDC follow some other councils in encouraging private residential owners to install water tanks to capture rainwater from the roof for use in the garden. TDC could make a bulk order, negotiate a discount, and onsell to locals wishing to put in a tank; Wellington or Porirua council have done this , which enabled us to get one via our daughter who lives in Tawa.

Waste Management and Minimisation Plan

WE APPROVE OF THE CHANGES PROPOSED IN THE WASTE MANAGEMENT PLAN, especially diversion of building waste. In our daily walks around Kokomea we see much useful building material put in a single bin along with real waste. Our grandparents used to say: "Wilful waste brings woeful want". We cannot dump our way to prosperity.

Treasury Management Policy

We **DO NOT** approve of the proposal to c hange to Net External Debt/Total Revenue Borrowing Limit from 225% to 250%. Council already has a high debt burden. Council only recently revised its debt to revenue limit from 200% to 225% of operating revenue. In 2016 Taupo District Council was eighth in the top 10 borrowers, and the highest of all the towns. We have not be en able to see where TDC sits now, but until that is revealed **WE OPPOSE ANY INCREASE IN THIS DEBT CEILING**. We detect an unwise "borrow and spend, borrow and spend" attitude. Borrowing in times of high inflation and interest rates is madness.

Housing

YES, TDC SHOULD USE LAND IT OWNS TO HELP EASE THE DISTRICT'S HOUSING CRISIS.

This is a continuing problem. We do not want Taupo to end up like Queenstown with a nextreme shortage of rental housing. Actually, there is no shortage of houses - there is a shortage of *available* housing. In Rainbow Point, where we live, only about 10-15% of the houses are permanently occupied. We estimate that in the Rainbow Point to Secombe Park area there are likely 500 to 1000 houses lying vacant for most of the year. We do not have an answer for this, but there must be a solution, even if it involves TDC building and operating rental property in conjunction with a private developer, or a scheme such as outlined below.

We suggest that TDC NOT SELL ITS LAND but instead LEASE it , initially to a building Developer/Company then to the persons who buy a new house from this Developer/Company. Over 50 years ago this was how we (in our mid-twenties) got our first house, in Wellington. Covenants could be placed on the arrangement to ensure that low-middle income, owner-occupiers, get the houses; if they leave they have to sell and the covenant remains. It could also be that long-term (say 8-10 years) owners could then free-hold the land at market value; Council then getting the advantage of rising property values.

OTHER MATTERS

Management of cats

To support the great community planting and pest trapping initiative led by Greening Taupo, we ask that TDC tackle the problem of cats (companion, stray, and feral). New Zealand is awash with cats. It is well established that cats are highly efficient predators, known to prey on native birds, lizards, and insects. We ask that controls around cats are included in the Animal Management Bylaw, and propose: a limit of three cats per household, microchipping, keeping cats inside at night, and compulsory de-sexing. There should definitely be regulations preventing the establishment and maintenance of feral and stray cat colonies, and action is taken against such colonies.

THIS IS A CAN THAT DOES NOT NEED KICKING DOWN THE ROAD.

Bulk purchase of electricity

We understand that large business corporations obtain, by negotiation, significant discounts on their cost of electricity. Why does TDC not negotiate a discounted rate for its residents and small businesses?. This would likely mean resurrecting TEL. And why not — it would be advantageous to most of the ratepayers. It seems that Council is willing to get involved in far more risky business ventures (motor racing circuit) that advantages just a few business sectors.



It is unfair and inconvenient for holiday home owners to be expected to pay for a wheelie bin which might only be put out occasionally. In Kuratau our collection day is on a Monday so the chances of us being there on any collection day - every 2nd week is remote. We then would also have the issue of getting our bin back inside if we put it out upon leaving at the end of a weekend visit. A wheelie bin left outside a property for a length of time would raise a security issue as it clearly signals people are not home. \$366 per year for a service we would hardly ever use seems unfair.

The current bag system allows us to pay as we use the system and if we are not there on collection day we can still drop the bag off at either the Kuratau transfer station or the Turangi transfer station on the way out of town to our permanent home.

The food waste system would be of little benefit to use for the same reasons as those above. Indeed we have a garbage grinder installed in our home sink so would continue using that.

I do not believe that wheelie bins provide an incentive for generating less rubbish. The 140 I bin is equivalent to more than 2 60 litre bags. A bag system applies in our home city and almost everyone using the system puts out only one bag at a time - weekly collection. Rarely are the bags damaged by dogs - indeed I cannot recall the last time of hat I observed a bag that had been damaged by a dog.

In summary we would suffer a decreased level of service for an increased price. Please stick with the bag system for rubbish. Perhaps small wheelie bins for non-glass recyclables can be justified as it would avoid the wind blown issue that currently arises with the open topped bins.
