At this time the only local newspaper available for publishing these notices is the Taupō and Tūrangi News. Applicants can email their classifieds section on classifieds@tauponews.co.nz or phone 07 3949530 for more information.

It is a requirement under the Sale and Supply of Alcohol Act 2012 that the newspaper notice be **published in the same newspaper twice with no less than 5 days and not more than 10 days between the two publications.**

Once published you are required to supply copies of the notices published to the Council as soon as reasonably possible. The copies must show the notice in the paper with the newspaper name and date (please do not send proofs or confirmation of notices to be published). If the notices are not supplied your application will not continue through the process and the granting of your licence will be delayed.

The full-page copy must be placed inside the entrance/ foyer of your premises for a period of 10 days after the first publication of the notice in the newspaper. Please note that while this notice must be displayed for at least 10 days the public have 25 working days to object to this application.

A copy of this public notice will also be placed on Council's website for at least 10 days.
