

IN THE MATTER of the Sale and Supply of Alcohol Act 2012 (the Act)

AND

IN THE MATTER of an application by Taupo Fishing Club Incorporated, for the renewal of a licence pursuant to Section 127 of the Sale and Supply of Alcohol Act 2012 in respect of the premises situated at 37 A C Baths Avenue, Taupo, and known as Taupo Fishing Club

The Application:

This is an application by Taupo Fishing Club Incorporated for the renewal of a Club Licence in respect of the Licensed Premises known as Taupo Fishing Club, situated at 37 A C Baths Avenue, Taupo.

The applicant is the holder of a Club Licence, Licence Number 20/CL/0001/2022 which was last varied by the Taupō District Licensing Committee on 10th June 2022.

The application was duly advertised on the Taupō District Council website from 24th June 2024 for a period of 10 days and no objection or notice of desire to be heard has been received. Display of the public notice has been carried out in the terms of the Sale and Supply of Alcohol Act 2012 by the licensee and no objections were lodged by any members of the public.

The Inspector has provided a comprehensive report that outlines the safe and responsible operation of this licence for many years.

Reasons for the Decision:

The applicant is a proven operator and has not come to notice in an adverse manner for any of the reporting agencies. The hours are reasonable, and the host responsibility practices appear sound.

The Club advises that they only open the bar for an hour or two once a week and have one certificated manager appointed to the Club. This is sufficient for this level of activity.


Should the Club begin to open the bar for additional hours a second certificated manager may be required.

The Decision:

We are satisfied as to the matters to which we must have regard as set out in the Act and approve the renewal of the licence for three years on the same conditions as previously granted by the Taupo District Licensing Committee.

I direct that a notice of renewal and a replacement licence be issued.

CLUB LICENCE

Sections 21 and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012 **TAUPO FISHING CLUB INCORPORATED** is authorised to sell and supply alcohol, on the premises situated at **37 A C Baths Avenue, Taupo** and known as **Taupo Fishing Club**, for consumption on the premises, to any person who-

- a) is a member of the club; or
- b) is on the premises at the invitation of, and is accompanied by, a member of the club; or
- c) is a member of some other club with which the club has an arrangement for reciprocal visiting rights for members; or
- d) is on the premises at the invitation of an authorised visitor who is also on the premises.

The authority conferred by this licence shall be exercised through a manager or managers appointed by the club in accordance with Sub-Part 7 of Part 2 of the Act.

CONDITIONS

This licence is subject to the following conditions:

1. Alcohol may be sold or supplied for consumption on the premises only on the following days and hours:
Monday to Friday from 4.00pm to 11.00pm; Saturday & Sunday from 12.00 noon to 12.00 midnight.
2. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises
3. The Licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
4. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence or menu variations of a similar range and standard. Menus must be visible, and food should be actively promoted.
5. The Licensee must provide information, advice and assistance about alternative forms of transport available to patrons from the licensed premises
6. Whilst the premises are open for the sale and supply of alcohol no "Bring Your Own" (BYO) alcohol may be consumed on the premises.
7. The Licensee must display:
 - a) At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
 - b) A copy of the licence.

THE LICENSED PREMISES

The sale, supply or consumption of alcohol is authorised in the premises generally. The premises situated at 37 AC Baths Avenue, Taupo, are more precisely identified as outlined in a plan date stamped as received by the Taupo District Licensing Committee on 18 August 2021.

DISPLAY OF LICENCE AND PRINCIPAL ENTRANCES

A copy of this licence must be displayed at the principal entrance to the premises. The entrance from the AC Baths Reserve carpark is designated as the principal entrance.

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force –

- a) until the close of the period for which it is renewed; or
- b) if an application for the renewal of the licence is duly made before it would otherwise expire, until the close of the period of 3 years after the period for which it is renewed.

This licence expires on 8 August 2027 unless further renewed
