# The Application:

This is an application by **Turangi Bowling Club Incorporated** for the renewal of a Club Licence in respect of the Licensed Premises known as Turangi Bowling Club, situated at 5 Katopu Street, Turangi.

The applicant is the holder of a Club Licence, Licence Number 20/CL/0017/2021 which was last renewed by the Taupō District Licensing Committee on 11th August 2021.

The application was duly advertised on the Taupō District Council website from 12 July 2024 for a period of 10 days and no objection or notice of desire to be heard has been received. Display of the public notice has been carried out in the terms of the Sale and Supply of Alcohol Act 2012 by the licensee and no objections were lodged by any members of the public.

The Inspector has provided a comprehensive report that outlines the safe and responsible operation of this licence for many years.

#### Reasons for the Decision:

The applicant is a proven operator and has not come to notice in an adverse manner for any of the reporting agencies. The hours are reasonable, and the host responsibility practices appear sound.

# The Decision:

We are satisfied as to the matters to which we must have regard as set out in the Act and approve the renewal of the licence for three years on the same conditions as previously granted by the Taupo District Licensing Committee.

I direct that a notice of renewal and a replacement licence be issued.

#### **CLUB LICENCE**

Sections 21 and 64, Sale and Supply of Alcohol Act 2012

**Pursuant** to the Sale and Supply of Alcohol Act 2012 <u>TURANGI BOWLING CLUB INCORPORATED</u> is authorised to sell and supply alcohol, on the premises situated at **5 Katopu Street**, **Turangi** and known as **Turangi Bowling Club**, for consumption on the premises, to any person who-

- a) is a member of the club; or
- b) is on the premises at the invitation of, and is accompanied by, a member of the club; or
- c) is a member of some other club with which the club has an arrangement for reciprocal visiting rights for members; or
- d) is on the premises at the invitation of an authorised visitor who is also on the premises.

The authority conferred by this licence shall be exercised through a manager or managers appointed by the club in accordance with Sub-Part 7 of Part 2 of the Act.

### **CONDITIONS**

This licence is subject to the following conditions:

- 1. Alcohol may be sold or supplied for consumption on the premises only on the following days and hours:
  - Sunday to Thursday from 8.00am to 10.30pm; and Friday, Saturday & Public Holidays from 8.00am to 12.00 midnight.
- 2. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises
- 3. The Licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages
- 4. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence or menu variations of a similar range and standard. Menus must be visible, and food should be actively promoted.
- 5. The Licensee must provide information, advice and assistance about alternative forms of transport available to patrons from the licensed premises
- 6. Whilst the premises are open for the sale and supply of alcohol no BYO alcohol may be consumed on the premises.
- 7. The Club must display:
  - a) At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
  - b) A copy of the licence attached to the inside of the premises so as to be easily read by persons using the premises

#### THE LICENSED PREMISES

The sale, supply or consumption of alcohol is authorised in the premises generally including the outdoor areas. The premises situated at 5 Katopu Street, Turangi are more precisely identified as outlined in a plan date stamped as received by the Taupo District Licensing Committee on 9 August 2018.

# **DISPLAY OF LICENCE AND PRINCIPAL ENTRANCES**

A copy of this licence must be displayed at the principal entrance to the premises. The entrance from Katopu Street, Turangi is designated as the principal entrance.

# **DURATION**

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force –

- a) until the close of the period for which it is renewed; or
- b) if an application for the renewal of the licence is duly made before it would otherwise expire, until the close of the period of 3 years after the period for which it is renewed.

This licence expires on 26 July 2027 unless further renewed
