Renewal of Manager's Certificate

Sale and Supply of Alcohol Act 2012

Please find attached your Manager's Certificate renewal, along with copies of the relevant reports, duly granted by the Taupō District Licensing Committee.

I wish to draw your attention to Section 214 of the Sale and Supply of Alcohol Act 2012 which states:

214 Manager to be on duty at all times and responsible for compliance

- (1) Except as provided in Section 215, a manager must be on duty at all times when alcohol is being sold or supplied to the public on any licensed premises.
- (2) A manager on duty on any licensed premises is responsible for—
 - (a) the compliance with and enforcement of—
 - (i) the provisions of this Act; and
 - (ii) the conditions of the licence in force for the premises; and
 - (b) the conduct of the premises with the aim of contributing to the reduction of alcohol-related harm.
- (3) At all times while a manager is on duty on any licensed premises, the full name of the manager must be prominently displayed inside the premises so as to be easily read by people using the premises; and the person named as manager at any time is to be treated for the purposes of this Act as the manager at that time.
- (4) At all times when alcohol is being sold or supplied on licensed premises the licensee must take all reasonable steps to enable the manager to comply with this section.

Your Manager's Certificate **does not** need to be displayed in a licensed premises but must be available for viewing by the Police or a Licensing Inspector.

The Application:

This is an application by Christopher John Wilson for the renewal of a Managers Certificate pursuant to Section 224 of the Sale and Supply of Alcohol Act 2012. It was formally received by the Taupō District Licensing Committee on 20th December 2018.

1. The applicant holds the Licence Controller Qualification and the LCQ Bridging Certificate and is employed in licensed premises.
2. The Licensing Inspector has provided a report outlining the applicant's experience in controlling licensed premises and has tested their understanding of their responsibilities as a Manager.
