The Application:

This is an application by Rebecca Rae Swanson for the renewal of a Managers Certificate pursuant to Section 224 of the Sale and Supply of Alcohol Act 2012. It was formally received by the Taupō District Licensing Committee on 26th April 2024.

Reasons for the Decision


1. The applicant holds the Licence Controller Qualification and the LCQ Bridging Certificate and is employed in licensed premises.

5. The application and supporting information satisfies the Committee that the criteria we must have regard to as set out in Section 227 of the Act have been met.
