DECISION OF THE TAUPŌ DISTRICT LICENSING COMMITTEE

The Application:

This is an application by Kelsey Marissa Gibbs for the renewal of a Managers Certificate pursuant to Section 224 of the Sale and Supply of Alcohol Act 2012. It was formally received by the Taupō District Licensing Committee on 13th May 2024.

Reasons for the Decision

1. The applicant holds the Licence Controller Qualification and is employed in licensed premises.
2. The Licensing Inspector has provided a report outlining the applicant's experience in controlling licensed premises and has tested their understanding of their responsibilities as a Manager.
3. Neither the New Zealand Police nor the Licensing Inspector express any concerns about the suitability of the applicant, nor do they oppose the renewal of the certificate. Accordingly, the application can be dealt with on the papers.
4. The application and supporting information satisfies the Committee that the criteria we must have regard to as set out in Section 227 of the Act have been met.

Decision of the Taupō District Licensing Committee:

The District Licensing Committee Commissioner, acting pursuant to the Sale and Supply of Alcohol Act 2012 approves the application by Kelsey Marissa Gibbs for the renewal of a Manager's Certificate.


However, we note that the applicant was apprehended for drink driving in March of 2024. An application was lodged with ARLA and her managers certificate has recently been suspended for 28 days from 12 July 2024.

When considering this renewal, the DLC is obliged to review previous conduct whilst holding a manager's certificate. We expect holders of managers certificates to set the example for their patrons.

Ms. Gibbs has consented to a truncated renewal and on that basis, we are prepared to approve a renewal.

The certificate is renewed for a further period of 18 months from the date of expiry of the current certificate.
