

IN THE MATTER of the Sale and Supply of Alcohol Act 2012 (the Act)

AND

IN THE MATTER of an application by Anand & Usha Sharma Limited for the variation and renewal of an OFF licence pursuant to Section 120 and 127 of the Sale and Supply of Alcohol Act 2012 in respect of the premises situated at 71 Rangatira Drive, Mangakino and known as "Mangakino Liquor Store".

THE APPLICATION

This is an application by Anand & Usha Sharma Limited for the variation and renewal of an Off Licence in respect of the licensed premises known as Mangakino Liquor Store, situated at 71 Rangatira Drive, Mangakino.

The applicant is the holder of an Off Licence, Licence Number 20/OFF/0115/2023 which was first granted by the Taupō District Licensing Committee on 22 May 2023.

The application was duly advertised on the Taupo District Council website from 27 March 2024 for a period of 10 days and no objection or notice of desire to be heard has been received. Display of the public notice has been carried out in the terms of the Sale and Supply of Alcohol Act 2012 by the licensee and no objections were lodged by any members of the public.

The Inspector has provided a comprehensive report that outlines the safe and responsible operation of this licence for the duration of the licence.

REASONS FOR THE DECISION

The applicant is a proven operator and has not come to notice in an adverse manner for any of the reporting agencies.

The applicant sought an extension of hours and the ability to sell RTDs that were deliberately forbidden in the 2023 decision.

The request to sell RTDs drew an opposed report from the MOoH. The matter was to be set down for a hearing until the applicant withdrew his request to sell RTDs.

The extension of hours will be approved. Contrary to the applicant's assertion RTDs and boating do NOT go together.

THE DECISION

We are satisfied with the matters to which we must have regard as set out in the Act and approve the renewal and variation of the licence for three years on amended conditions.

I direct that a notice of renewal and a replacement licence be issued.

Notice of Renewal of Off Licence

Section 135, Sale and Supply of Alcohol Act 2012

The Off Licence in respect of the premises situated at 71 Rangatira Drive, Mangakino known as “**Mangakino Liquor Store**” is renewed.

The present conditions of the licence continue to apply subject to the following changes:

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licenses, the licence continues in force—

OFF LICENCE

Sections 17 to 20, and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012, **Anand & Usha Sharma Limited** is authorised to sell or deliver alcohol on or from the premises situated at 71 Rangatira Drive, Mangakino, and known as **Mangakino Liquor Store**, to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises.

If this licence is not endorsed under section 40 of the Act, the licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager, or managers, appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

CONDITIONS

This licence is subject to the following conditions:

1. Alcohol may be sold on, or delivered from, the premises for consumption off the premises, or supplied free as a sample for consumption on the premises, only on the following days and hours: **Tuesday to Sunday from 11.00am to 7.00pm.**
2. No alcohol is to be sold on, or delivered from, the premises on Good Friday, Easter Sunday or Christmas Day or before 1.00pm on Anzac Day.
3. While alcohol is being supplied free as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.
4. **The whole of the premises is designated as a Supervised Area.**
5. The Licensee must have available for consumption off the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
6. A properly appointed certificated or Acting or Temporary Manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the premises.
7. **Only beer, cider and wine, and standard size 700ml to 1150ml bottles of spirits can be sold under this licence.**
8. **No shots, RTDs, spirit miniatures or crated beer are to be sold.**
9. The Licensee must display:
 - a) At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
 - b) At the principal entrance to the premises, so as to be easily read by people immediately outside the premises, a sign stating the ordinary hours of business during which the premises will be open for sale of alcohol;
 - c) A copy of the licence attached to the inside of the premises so as to be easily read by people entering each principal entrance.

THE LICENSED PREMISES

The sale or delivery of alcohol is authorised in or from the premises generally. The premises situated at 71 Rangatira Drive, Mangakino are more precisely identified as outlined in a plan date stamped as received by the Taupo District Licensing Committee on 20 January 2022.

DISPLAY OF LICENCE AND PRINCIPAL ENTRANCE

A copy of this licence must be displayed at the principal entrance to the premises. The entrance from 71 Rangatira Drive is designated as the principal entrance.

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences this licence continues in force –

- until the close of the period for which it is renewed; or
- if an application for the renewal of the licence is duly made before it would otherwise expire, until the close of the period of 1 years after the period for which it is renewed.

This licence expires on 22 May 2027 unless further renewed
