# THE APPLICATION

This is an application by Global Beverages NZ Limited for the renewal of an Off Licence in respect of the licensed premises known as Whisky and More, situated at 118 Spa Road, Taupo.

The applicant is the holder of a Off Licence, Licence Number 20/OFF/0076/2021 which was last renewed by the Taupō District Licensing Committee on 11th October 2021.

# OFF LICENCE

(for Remote Sales) Sections 17 to 20, and 64, Sale and Supply of Alcohol Act 2012

**Pursuant** to the Sale and Supply of Alcohol Act 2012, <u>Global Beverages NZ Limited</u> is authorised to sell or deliver alcohol from (but not on) the premises situated at 118 Spa Road, Taupo, and known as Whisky and More, to any person for consumption off the premises.

### ENDORSEMENT

Section 40 of the Act applies to this licence and the licensee is authorised to sell alcohol from (but not on) the premises and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager, or managers, appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

#### CONDITIONS

This licence is subject to the following conditions:

- Alcohol may be sold from the premises at any time on any day, and delivered somewhere else for consumption off the premises only on the following days and hours: Monday to Sunday from 6.00am to 11.00pm.
- 2. No alcohol is to be delivered from the premises on Good Friday, Easter Sunday or Christmas Day or before 1.00 pm on Anzac Day
- 3. No alcohol is to be delivered to the buyer (or to any other person on the buyer's behalf) at any time between 11:00pm and 6:00am the following day, on any day of the week
- 4. A properly appointed certificated or Acting or Temporary Manager must be appointed by the licensee.
- 5. The Licensee must follow the procedures set out in Regulation 14 of the Sale and Supply of Alcohol Regulations 2013 to ensure that neither the purchaser nor the person to whom alcohol is delivered is a minor.
- 6. The Licensee must display on its website and/or in its catalogue and on every receipt issued for alcohol sold remotely:
  - a. The licence holder's name and licence number,
  - b. The date on which the licence expires,
  - c. A legible image of the licence or a clearly identified link to such an image.

#### THE LICENSED PREMISES

The sale, supply or consumption of alcohol is authorised in the premises generally. The premises situated at 118 Spa Road, Taupo are more precisely identified as outlined in a plan date stamped as received by the Taupo District Licensing Committee on 16 July 2014. A copy of this licence must be displayed as prescribed in condition 6 of this licence.

#### DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences this licence continues in force –

- until the close of the period for which it is renewed; or
- if an application for the renewal of the licence is duly made before it would otherwise expire, until the close of the period of 3 years after the period for which it is renewed.
