AND

IN THE MATTER of an application by Dixie Brown`s Limited for the renewal of an ON licence pursuant to Section 127 of the Sale and Supply of Alcohol Act 2012 in respect of the premises situated at 38 Roberts Street, Taupo and known as “**Dixie Brown`s Restaurant**”

The Application:

This is an application by Dixie Brown`s Limited for the renewal of an On Licence in respect of the licensed premises known as Dixie Brown`s Restaurant, situated at 38 Roberts Street, Taupo.

The applicant is the holder of a On Licence, Licence Number 20/ON/0392/2023 which was first granted by the Taupō District Licensing Committee on 12 October 2023

The application was duly advertised on the Taupo District Council website from 1 July 2024 for a period of 25 working days and no objection or notice of desire to be heard has been received. Display of the public notice has been carried out in the terms of the Sale and Supply of Alcohol Act 2012 by the licensee and no objections were lodged by any members of the public.

The Inspector has provided a comprehensive report that outlines the safe and responsible operation of this licence for the renewal period.

The Reasons for the Decision:

The applicant is a proven operator and has not come to notice in an adverse manner for any of the reporting agencies. The hours are reasonable and the host responsibility practices appear sound.

The Decision:

We are satisfied as to the matters to which we must have regard as set out in the Act and approve the renewal of the licence for three years on the same conditions as previously granted by the Taupo District Licensing Committee.

I direct that a notice of renewal and a replacement licence be issued.
