The Application:

This is an application by Simon Dickie Adventures Limited for the renewal of an On Licence in respect of the licensed premises known as Ernest Kemp Cruises, situated at Taupo Boat Harbour, Redoubt Street, Taupo.

The applicant is the holder of a On Licence, Licence Number 20/ON/0116/2021 which was last renewed by the Taupō District Licensing Committee on 3rd February 2022.

The application was duly advertised on the Taupo District Council website from 14 November 2024 for a period of 25 working days and no objection or notice of desire to be heard has been received. Display of the public notice has been carried out in the terms of the Sale and Supply of Alcohol Act 2012 by the licensee and no objections were lodged by any members of the public.

We are satisfied as to the matters to which we must have regard as set out in the Act and approve the renewal of the licence for three years on the same conditions as previously granted by the Taupo District Licensing Committee.

ON-LICENCE

(for Conveyance)

Sections 14 to 16 and 64 of the Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012, **SIMON DICKIE ADVENTURES LIMITED** is authorised to sell and supply alcohol, on the vessel known as **"Ernest Kemp Cruises"** based at Taupo Boat Harbour, Redoubt Street, Taupo, and journeying on Lake Taupo, to any person present on the vessel and to allow the consumption of alcohol on the conveyance by any such person.

CONDITIONS

This licence is subject to the following conditions:

- Alcohol may be sold or supplied for consumption on the premises only on the following days and hours: During the
 period of any scheduled public cruise or private function, but not other than on the following days & hours:
 Monday to Sunday from 10.00am to 12.00 midnight.
- No alcohol is to be sold or supplied on the premises on Good Friday, Easter Sunday, Christmas Day or before 1.00pm on Anzac Day.
- 3. Free drinking water is to be available at all times when the conveyance is open for the sale and supply of alcohol.
- 4. The Licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
- 5. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence or menu variations of a similar range and standard. Menus must be visible, and food should be actively promoted.
- 6. A properly appointed certificated or Acting or Temporary Manager must be on duty at all times when the premises are open for the sale and supply of alcohol, and their full name must be on a sign prominently displayed in the premises.
- 7. The Licensee must provide information, advice and assistance about alternative forms of transport available to patrons from the licensed vessel.
- 8. The Licensee must display:
 - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons,
 - b. At the principal entrance to the premises, so as to be easily read by people immediately outside the premises, a sign stating the ordinary hours of business during which the premises will be open for sale of alcohol,
 - c. A copy of the licence attached to the premises so as to be easily read.

THE LICENSED PREMISES

The sale, supply or consumption of alcohol is authorised on the vessel generally. The premises situated at Berth #2, Taupo Boat Harbour, Redoubt Street, Taupo, are more precisely identified as outlined in a plan date stamped as received by the Taupo District Licensing Committee on 3 December 2002.

DISPLAY OF LICENCE AND PRINCIPAL ENTRANCES

A copy of this licence must be displayed at the principal entrance to the premises. The entrance from the stern of the vessel is designated as the principal entrance.

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force -

- a) Until the close of the period of 1 year commencing with the date of its issue; or
- b) If an application for the renewal of the licence is duly made, until the application is determined; or
- c) If the licence is renewed, until the close of the period of 3 years after the period for which it was renewed.

This licence expires on 24 December 2027 unless further renewed
