The Application

This is an application by Dean Fleming for an off site Special Licence pursuant to Section 138 of the Sale and Supply of Alcohol Act 2012 for the Turangi Market. It was formally received by the Taupō District Licensing Committee on 4th June 2024.

Reasons for the Decision

The applicant appears to be a responsible entity to hold a Special Licence and a certificated manager will oversee the sale, supply and consumption of alcohol.


The Police and Medical Officer of Health reports raise no matters in opposition.

Off Site Special Licence

Section 22 and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012, **Dean Fleming** is authorised to sell and supply alcohol, on the premises situated at the Turangi Town Centre Mall, Town Centre, Turangi and known as the Turangi Market for consumption off the premises, to any person attending the following occasion or event (or series of occasions or events): **Turangi Market**.

The authority conferred by this licence must be exercised through a managers or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Sale and Supply of Alcohol Act 2012.

CONDITIONS

This licence is subject to the following conditions:

1. Alcohol may be sold and supplied for consumption on the premises only on the following days and hours:
Saturday 15 June 2024, Saturday 29 June 2024, Saturday 6 July 2024, Saturday 13 July 2024, Saturday 20 July 2024, Saturday 27 July 2024, Saturday 3 August 2024, Saturday 10 August 2024, Saturday 17 August 2024, Saturday 24 August 2024, Saturday 31 August 2024, Saturday 7 September 2024, Saturday 14 September 2024, Saturday 21 September 2024, Saturday 28 September 2024, Saturday 5 October 2024, Saturday 12 October 2024, Saturday 19 October 2024. From 8.30am to 1.00pm on each date.
2. While alcohol is being supplied as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.
3. A certificated manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the stall.
4. The Licensee must display signage as follows:
 - a. At every point-of-sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons,
 - b. A copy of the licence is to be attached to the stall so as to be easily read by people attending the licensed area.

DURATION

This licence is only in force as specified in Condition 1.

THE LICENSED PREMISES

The licensed premises known as the "Turangi Market" situated at the Town Centre Mall, Turangi, is more precisely identified as outlined in the Event Site Plan provided with the application, as received by the Taupo District Licensing Committee on 4th June 2024.
