# **Off Site Special Licence**

Section 22 and 64, Sale and Supply of Alcohol Act 2012

**Pursuant** to the Sale and Supply of Alcohol Act 2012, **Cardrona Distillery Limited** is authorised to sell and supply alcohol, on the premises situated at 114 Rapids Road, Taupo and known as National Equestrian Centre for consumption off the premises, to any person attending the following occasion or event (or series of occasions or events): **Bayleys Sheep Dog Trials 2024.** 

The authority conferred by this licence must be exercised through a managers or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Sale and Supply of Alcohol Act 2012.

#### **CONDITIONS**

This licence is subject to the following conditions:

- Alcohol may be sold and supplied for consumption off the premises only on the following days and hours: Wednesday 19 June 2024 from 10.00am to 7.00pm; Thursday 20 June 2024 from 10.00am to 7.00pm; Friday 21 June 2024 from 10.00am to 7.00pm; & Saturday 22 June 2024 from 10.00am to 7.00pm.
- 2. <u>Tasting samples of 5ml to 10ml in 25ml size tasting cups will be provided, and patrons are only permitted to taste a maximum of five samples each.</u>
- 3. While alcohol is being supplied as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.
- 4. A certificated manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the stall.
- 5. The Licensee must display signage as follows:
  - a. At every point-of-sale detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons,
  - b. A copy of the licence is to be attached to the stall so as to be easily read by persons attending the licensed area.

## **DURATION**

This licence is only in force as specified in Condition 1.

#### THE LICENSED PREMISES

The licensed premises known as the Cardrona Distillery Limited situated at The National Equestrian Centre (NEC), 114 Rapids Road, RD 2, Taupo, is more precisely identified as outlined in the event site plan provided with the application as received by the Taupo District Licensing Committee on 27 May 2024.
