# **Off Site Special Licence**

Section 22 and 64, Sale and Supply of Alcohol Act 2012

**Pursuant** to the Sale and Supply of Alcohol Act 2012, **5 Mile Distilling Limited** is authorised to sell and supply alcohol, on the premises situated at Northcroft Street, and known as Northcroft Reserve, Taupo for consumption off the premises, to any person attending the following occasion or event (or series of occasions or events): **Market Central Taupo.** 

The authority conferred by this licence must be exercised through a managers or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Sale and Supply of Alcohol Act 2012.

#### CONDITIONS

This licence is subject to the following conditions:

- 1. Alcohol may be sold on, or delivered from, the premises for consumption off the premises, or supplied as a sample for consumption on the premises, only on the following days and hours:
  - Every Sunday from 4 August 2024 to 3 August 2025 from 8.30am to 2.00pm on each date.
- 2. The proposed licensed area (being a 3m x3m gazebo open-air stall) is designated as a <u>Supervised area</u>, as identified on the site plan date stamped as received by Taupo District Licensing Committee on 10 July 2024.
- 3. While alcohol is being supplied as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.
- 4. A certificated manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed.
- 5. The Licensee must display signage as follows:
  - a. At every point-of-sale detailing restriction on the sale and supply of alcohol to minors and intoxicated persons,
  - b. A copy of the licence is to be attached to stall to be easily read by people attending the licensed area.

## **DURATION**

This licence is only in force as specified in Condition 1.

## THE LICENSED PREMISES

The licensed premises known as 5 Mile Distilling situated at Northcroft Reserve, Northcroft Street, Taupo is more precisely identified as outlined in the event site plan provided with the application as received by the Taupo District Licensing Committee on 10 July 2024.
