**The Application**

This is an application by 5 Mile Distilling Limited for an off site Special Licence pursuant to Section 138 of the Sale and Supply of Alcohol Act 2012 for The Kinloch Market Day. It was formally received by the Taupō District Licensing Committee on 13th September 2024.

**Reasons for the Decision**

The applicant appears to be a responsible entity to hold a Special Licence and a certificated manager will oversee the sale, supply and consumption of alcohol.


The Police and Medical Officer of Health reports raise no matters in opposition.

## Off Site Special Licence

*Section 22 and 64, Sale and Supply of Alcohol Act 2012*

**Pursuant** to the Sale and Supply of Alcohol Act 2012, **5 Mile Distilling Limited** is authorised to sell and supply alcohol, on the premises situated at 557 Palmer Mill Rd, Taupo, and known as Kinloch Domain for consumption off the premises, to any person attending the following occasion or event (or series of occasions or events): **The Kinloch Market Day.**

The authority conferred by this licence must be exercised through a managers or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Sale and Supply of Alcohol Act 2012.

### CONDITIONS

This licence is subject to the following conditions:

1. Alcohol may be sold and supplied for consumption on the premises only on the following days and hours:  
**Sunday 27 October 2024 from 8.30am to 4.30pm.**
2. The 3m x 3m gazebo market stall shall be designated as a Supervised area.
3. While alcohol is being supplied as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.
4. A certificated manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed.
5. The Licensee must display signage as follows:
  - a. At every point-of-sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons,
  - b. A copy of the licence is to be attached to stall so as to be easily read by people attending the licensed area.

### DURATION

This licence is only in force as specified in Condition 1.

### THE LICENSED PREMISES

The licensed premises known as 5 Mile Distilling, situated at The Kinloch Market Day, Kinloch Domain, Mata Place, Kinloch, Taupo, is more precisely identified as outlined in the event site plan provided with the application as received by the Taupo District Licensing Committee on 7 September 2024.
