**The Application**

This is an application by ZOA Limited for an off site Special Licence pursuant to Section 138 of the Sale and Supply of Alcohol Act 2012 for the NZMCA Second-Hand Motorhome & Caravan Show. It was formally received by the Taupō District Licensing Committee on 27 September 2024.

**Reasons for the Decision**

The applicant appears to be a responsible entity to hold a Special Licence and a certificated manager will oversee the sale, supply and consumption of alcohol.


The Police and Medical Officer of Health reports raise no matters in opposition.

We are satisfied as to the matters to which we must have regard as set out in the Act and we grant the applicant a Special Licence authorising the sale and supply of alcohol to any person attending the following occasion or event (or series of occasions or events): NZMCA Second-Hand Motorhome & Caravan Show.

The licence shall be subjected to mandatory and discretionary conditions as detailed in the attached licence.

## Off Site Special Licence

*Section 22 and 64, Sale and Supply of Alcohol Act 2012*

**Pursuant** to the Sale and Supply of Alcohol Act 2012, **ZOA Limited** is authorised to sell and supply alcohol, on the premises situated at 5 Story Place, Taupo and known as Great Lake Centre, for consumption off the premises, to any person attending the following occasion or event (or series of occasions or events): **NZMCA Second-Hand Motorhome & Caravan Show**.

The authority conferred by this licence must be exercised through a managers or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Sale and Supply of Alcohol Act 2012.

### CONDITIONS

This licence is subject to the following conditions:

1. Alcohol may be sold on, or delivered from, the premises for consumption off the premises, or supplied as a sample for consumption on the premises, only on the following days and hours:  
**Saturday 2 November 2024 from 9.00am to 5.00pm; and**  
**Sunday 3 November 2024 from 9.00am to 4.00pm.**
2. Tasting samples of up to 15ml of alcoholic spirit (with a mixer) in tasting cups will be provided, and patrons are only permitted to taste a maximum of four samples each.
3. While alcohol is being supplied as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.
4. A certificated manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the stand (number 14).
5. The Licensee must display:
  - a. At every point-of-sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons,
  - b. A copy of the licence is to be attached to stall so as to be easily read by people attending the licensed area.

### DURATION

This licence is only in force as specified in Condition 1.

### THE LICENSED PREMISES

The licensed premises known as the ZOA @ the Campsaver Secondhand Motorhome and Caravan Show, situated at stand number 14 at The Great Lake Centre, 5 Story Place, Taupo, is more precisely identified as outlined in the event site plan provided with the application as received by the Taupo District Licensing Committee on 27 September 2024.
