**The Application**

This is an application by Mr Dean Richard Fleming for an off site Special Licence pursuant to Section 138 of the Sale and Supply of Alcohol Act 2012 for the Turangi Markets. It was formally received by the Taupō District Licensing Committee on 15th October 2024.

**Reasons for the Decision**

The applicant appears to be a responsible entity to hold a Special Licence and a certificated manager will oversee the sale, supply and consumption of alcohol.


The Police and Medical Officer of Health reports raise no matters in opposition.

## Off Site Special Licence

*Section 22 and 64, Sale and Supply of Alcohol Act 2012*

**Pursuant** to the Sale and Supply of Alcohol Act 2012, **Mr Dean Richard Fleming** is authorised to sell and supply alcohol, on the premises situated at Turangi Town Centre Mall, Turangi, and known as Turangi Town Centre for consumption off the premises, to any person attending the following occasion or event (or series of occasions or events): **Turangi Markets.**

The authority conferred by this licence must be exercised through a managers or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Sale and Supply of Alcohol Act 2012.

### CONDITIONS

This licence is subject to the following conditions:

1. Alcohol may be sold on, or delivered from, the premises for consumption off the premises, or supplied as a sample for consumption on the premises, only on the following days and hours:  
**Every Saturday from 16 November 2024 to 26 April 2025. From 8.30am to 1.00pm on each date.**
2. While alcohol is being supplied as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.
3. A certificated manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the stall.
4. The Licensee must display:
  - a. At every point-of-sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons,
  - b. A copy of the licence is to be attached to stall so as to be easily read by people attending the licensed area.

### DURATION

This licence is only in force as specified in Condition 1.

### THE LICENSED PREMISES

The licensed premises known as Tui Street Gin situated at the Turangi Market, Turangi Town Centre Mall, Turangi, is more precisely identified as outlined in the event site plan provided with the Taupo District Licensing Committee on 15 October 2024.
