Off Site Special Licence

Section 22 and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012, **Mr Dean Richard Fleming** is authorised to sell and supply alcohol, on the premises situated at Rangatira Drive, Mangakino and known as Rangatira Drive Quadrant, Mangakino for consumption off the premises, to any person attending the following occasion or event (or series of occasions or events): **Mangakino Market.**

The authority conferred by this licence must be exercised through a managers or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Sale and Supply of Alcohol Act 2012.

CONDITIONS

This licence is subject to the following conditions:

- 1. Alcohol may be sold on, or delivered from, the premises for consumption off the premises, or supplied as a sample for consumption on the premises, only on the following days and hours:
 - Saturday 30 November 2024 from 9.30am to 2.30pm.
- 2. While alcohol is being supplied as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.
- 3. A certificated manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the stall.
- 4. The Licensee must display:
 - a. At every point-of-sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons,
 - b. A copy of the licence is to be attached to stall so as to be easily read by people attending the licensed area

DURATION

This licence is only in force as specified in Condition 1.

The licensed premises known as Tui Street Gin situated at the Mangakino Market, Rangatira Drive Quadrant, Rangatira Drive, Mangakino, is more precisely identified as outlined in the event site plan provided with the Taupo District Licensing Committee on 23 October 2024.
