Off Site Special Licence

Section 22 and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012, **Beehave Meadery Limited** is authorised to sell and supply alcohol, on the premises situated at Northcroft Street, Taupo, and known as Northcroft Reserve, for consumption off the premises, to any person attending the following occasion or event (or series of occasions or events): **Market Central Taupo.**

The authority conferred by this licence must be exercised through a managers or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Sale and Supply of Alcohol Act 2012.

CONDITIONS

This licence is subject to the following conditions:

- 1. Alcohol may be sold on, or delivered from, the premises for consumption off the premises, or supplied as a sample for consumption on the premises, only on the following days and hours:
 - Thursday 19 December 2024 from 4.30pm to 8.30pm. Sunday 22 December 2024, Sunday 29 December 2024, Sunday 5 January 2025, Sunday 12 January 2025 & Sunday 19 January 2025 <u>from 8.00am to 1.00pm on the</u> dates as listed.
- 2. While alcohol is being supplied as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.
- 3. A certificated manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the stall.
- 4. The Licensee must display:
 - a. At every point-of-sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons,
 - b. A copy of the licence is to be attached to stall so as to be easily read by people attending the licensed area.

DURATION

This licence is only in force as specified in Condition 1.

THE LICENSED PREMISES

The licensed premises known as the Beehave Craft Meadery, situated at Taupo Market Central, Northcroft Reserve, Northcroft Street, Taupo, is more precisely identified as outlined in the event site plan provided with the application as received by the Taupo District Licensing Committee on 11 November 2024.
