

**IN THE MATTER** of the Sale and Supply of Alcohol Act 2012 (the Act)

**AND**

**IN THE MATTER** of an application by Taupo Spice World Limited pursuant to Section 136(1) of the Sale and Supply of Alcohol Act 2012 for a Temporary Authority in respect of the premises situated at 1001 Anzac Memorial Drive (Private), Tau and known as "Lil Something".

This is an application by Taupo Spice World Limited for a Temporary Authority for a premises situated at 1001 Anzac Memorial Drive (Private), Tau to be known as Lil Something.

There is a substantive Temporary Authority in place with the licence number 20/ON/0351/2022 that expires on 3 May 2025.

The application contains supporting documentary evidence indicating that a Sale & Purchase/ Lease agreement has been completed for the business. Takeover was on the 31st of May 2024.

Accordingly, the application is to be dealt with by the committee on the papers.

**REASONS FOR THE DECISION**

Neither the New Zealand Police nor the Licensing Inspector express any concerns about the suitability of the applicant, nor do they oppose the granting of the order.

**THE DECISION**

The application and supporting information satisfies us that the criteria we must have regard to as set out in s.136 of the Act has been met.


Section 136(5) of the Act says the person authorised by the order has for the purposes of this Act the same duties, obligations, and liabilities as the holder of the on-licence or off-licence concerned.

We remind the applicant that a properly appointed certificated, or Acting or Temporary Manager must be on duty at all times the premises is open for the sale and supply of alcohol.

The District Licensing Committee, acting pursuant to the Sale and Supply of Alcohol Act 2012 makes an order for a Temporary Authority ON Licence with the existing conditions on the base licence continuing to apply:

- **The Order is to run for 3 months from the 31st of May 2024;**
- **The substantive ON Licence application must be lodged within 5 working days of receipt of the planning certificate from council.**

## Taupo District Licensing Committee

### Temporary Authority

*Section 136(1) of the Sale and Supply of Alcohol Act 2012*

Pursuant to Section 136(1) of the Sale and Supply of Alcohol Act 2012 the Taupo District Council in its capacity as District Licensing Committee has made an order authorising **Taupo Spice World Limited** to carry on the sale and supply of alcohol for consumption on the premises known as **Lil Something**, situated at, **1001 Anzac Memorial Drive (Private), Tau.**

This Temporary Authority shall be in force from **31 May 2024** until the substantive licence application lodged by **Taupo Spice World Limited** is determined, or until **31 August 2024**, whichever is the sooner.

This Temporary Authority is issued subject to the following conditions:

- **The order is to run for 3 months from the 31 May 2024**
- **The substantive ON Licence application must be lodged within 5 working days of receipt of the planning certificate from council.**

The person authorised by this order, has for the purposes of this Act, the same duties, obligations, and liabilities as the holder of the on licence concerned.
