

IN THE MATTER of the Sale and Supply of Alcohol Act 2012 (the Act)

AND

IN THE MATTER of an application by Chaku and Co Limited pursuant to Section 136(1) of the Sale and Supply of Alcohol Act 2012 for a Temporary Authority in respect of the premises situated at 3 Rainbow Drive, Taupo and known as "Rainbow Point Store".

This is an application by Chaku and Co Limited for a Temporary Authority for a premises situated at 3 Rainbow Drive, Taupo to be known as Rainbow Point Store.

There is a substantive Temporary Authority in place with the licence number 20/OFF/0012/2022 that expires 19th of October 2025.

The application contains supporting documentary evidence indicating that a Sale & Purchase/ Lease agreement has been completed for the business. Takeover was on the 30 October 2023. No alcohol has been sold at the premises since that date.

Accordingly, the application is to be dealt with by the committee on the papers.

REASONS FOR THE DECISION

Neither the New Zealand Police nor the Licensing Inspector express any concerns about the suitability of the applicant, nor do they oppose the granting of the order.

We remind the applicant that a properly appointed experienced and certificated, must be on duty at all times when the premises is open for the sale and supply of alcohol.

THE DECISION


The application and supporting information satisfy us that the criteria we must have regard to as set out in s.136 of the Act has been met.

Section 136(5) of the Act says the person authorised by the order has for the purposes of this Act the same duties, obligations, and liabilities as the holder of the on-licence or off-licence concerned.

The District Licensing Committee, acting pursuant to the Sale and Supply of Alcohol Act 2012 makes an order for a Temporary Authority OFF Licence with the existing conditions on the base licence continuing to apply:

- **The Order is to run for 3 months from the 4th of June 2024 or until the substantive application is determined.**

Temporary Authority

Section 136(1) of the Sale and Supply of Alcohol Act 2012

Pursuant to Section 136(1) of the Sale and Supply of Alcohol Act 2012 the Taupo District Council in its capacity as District Licensing Committee has made an order authorising **Chaku and Co Limited** to carry on the sale and supply of alcohol for consumption elsewhere from the premises known as **Rainbow Point Store**, situated at, **3 Rainbow Drive, Taupo**.

This Temporary Authority shall be in force from **4 June 2024** until the substantive licence application lodged by **Chaku and Co Limited** is determined, or until **4 September 2024**, whichever is the sooner.

This Temporary Authority is issued subject to the following conditions:

- The order is to run for 3 months from the 4 June 2024

The person authorised by this order, has for the purposes of this Act, the same duties, obligations, and liabilities as the holder of the on licence concerned.
