Development is inevitable, and I think that it is important that it is carried out by high-quality developers like Seven Oaks, who give back to the community. Seven Oaks has a proven track record of delivering exceptional developments in Kinloch, which many in the community will undoubtedly welcome. Their application represents a practical and necessary development of this land, with section sizes that are typical for Kinloch.

I appreciate that Seven Oaks revised their plans based on community feedback, eliminating smaller sections and opting for an average section size of 1,000 m², with many larger sections at 2,500 m², and increased reserve spaces. This demonstrates their commitment to community needs, as does their generous donation of a site for a kindergarten.

While it would be easy to fall into the trap that I want the village to remain the size it is now, I know that is unrealistic and would rather we get high quality development than substandard development that is common elsewhere. The positive effects of this proposal will be substantial for the future of Kinloch, providing high-quality housing and attracting more people to support the upcoming commercial project led by another developer.
